REMEMBER: USPS Mail is now 30% slower on delivery, so if you're sending payment via USPS Mail, the deadline for RECEIPT of payment is still Friday, 12/10/21.

CEBGDC will add a collection fee to the amount of each returned check or money order.

CLASSIFICATIONS for the Field Trial

T.A.N. Dogs entering T.A.N. must be three years of age or less on the day of the T.A.N., must be registered with the UKC or the TL or LP number and may not have already earned a T.A.N. previously.

W.R.T. – The WRT is open to all pointing breed dogs that are Permanently Registered, Temporary Listed (TL), or Performance Listed (PL) with the UKC. This shall include dogs which are neutered. The minimum age of a dog to be eligible for entry is that the dog must be at least six (6) months of age as of the date of the WRT event. There is no maximum age limitation.

All dogs six (6) months of age or older must have inoculations for Rabies, Canine Distemper, and Canine Parvovirus to be eligible to participate in a UKC Licensed TAN event.

Dogs under six (6) months of age present on the grounds where any UKC Licensed TAN or other event is being held must have current inoculations for Canine Distemper and Parvovirus.

Field Trial: There are two Classes, Open and Gun Dog

- A. Gun Dog Class.** The Gun Dog Class shall be open to dogs six (6) months or older and which have not earned a title in the Open Dog Class and registered with the UKC or with TL or LP number. The Gun Dog Class is designed for beginning and intermediate level dogs and handlers. In Type (L) field trials involving liberated (released) birds, the Gun Dog Class shall be run in solo only.
- B. Open Dog Class.** The Open Dog Class shall be open to dogs at least one (1) year of age or older registered with the UKC or with TL or LP number.

Dogs in heat may participate in the field trial. Dogs in season will be run last and kept away from other dogs at all times until their run order.

Subject to the specific information set forth herein, the CEBGDC Field Trial Committee hereby adopts by reference and expressly incorporates the United Kennel Club Inc. Field Trial and TAN Rules and Regulations Standard Premium List Template within the current OFFICIAL UKC POINTING DOG RULE BOOK using updates when they become available.

NOTE: All owners and handlers must sign the release and waiver of liability, which is a part of the entry form, as a condition of event participation.

TRIAL AREA AND TYPE

The December 18th & 19th, 2021 Field Trial will be conducted in tall, open pines and thick briar bottoms. A good set of chaps is recommended. The trials will be Type L (liberated bird). **The handler is require to read, be familiar with, and abide by the T.A.N., W.R.T, and Field Trial Rules as published by U.K.C.**

The drawn running order is a *guideline* as to running order and time. Handlers and their dogs must be readily available at the judges' disposal to accommodate any change in running order. All dogs not needed for further judging will be excused.

SUBMITTING ENTRIES

Carolinas Epagneul Breton Gun Dog Club wants to be as digital as possible. Our request is that all forms and payments be handled online. However, we will accept entries and payment (check or money order) for entries via USPS.

****We are not responsible for actions of the USPS and any late or non-deliveries. Deadline for mail deliveries is Monday, December 13, 2021.**

Entries will be deemed accepted only after correct payment has been received along with the fully completed Entry Form. Entries received without fees will not be accepted.

For Digital Entries and Payments:

1. Entries must include the fully completed Entry Form on the Official U.K.C.

2. Print one form per dog per date of field trial. After completing the Entry Form(s), determine your total payment due, then go [HERE](#) to submit payment via the link for the Club's **PayPal account**. *Under **NOTES** on PayPal, please note the name of your dogs to help ensure matching dogs with payments.*

3. **Scan the completed Entry Form(s) to your computer. Submit the Entry Form(s) to the Field Trial Secretary via email: events@carolinasebgdc.com**

****NOTE:** The Online Submission requires only one additional step verses sending by mail—i.e. scanning the signed document. Otherwise, you're doing the same number of steps to send a check. The deadline for **digital** entries and **digital** payments is **Wednesday, December 15, 2021**.

For Check or Money Order Payments for Entries:

1. Entries must include the fully completed Official U.K.C. Entry Form. Click [HERE](#) for entry form.
2. Entries will be deemed accepted only after correct payment has been received along with the fully completed Entry Form. Entries received without fees will not be accepted. Print the Entry Form, complete one form per dog, sign, date and mail.

Post-dated checks or returned checks do not constitute a valid entry. Carolinas EBGDC will add a collection fee to the amount of each returned check or money order. Contestants who repeatedly submit invalid entry fees may be put on a CASH ONLY basis.

NOTE: USPS Mailed entries must be received by Monday, 12-13-2021.

The Field Trial Committee reserves the right to reject any late entry, depending upon space, birds, logistics and other considerations. The running order of any dog entered late and after the drawing of the running order shall be solely at the discretion of the Field Trial Chairman and Secretary.

REFUNDS

1. No refund of entry fees will be made for entries cancelled after the Entry deadline if an event is cancelled due to lack of entries or other consideration.
2. Entry fees shall not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of Event Committee.
3. If, because of riots, civil disturbances, inclement weather, pandemic mandates, or other acts beyond the control of the host organization, it is impossible to open or to complete a show or trial, no refund of entry fee may be made if it is necessary to cover non-refundable incurred expenses.
4. If, in the opinion of the host club, the well-being of dogs, exhibitors or spectators is at risk due to extreme weather conditions, such as, but not limited to snow storms, hurricanes, lightning, or extreme heat, the host club may cancel or stop a show or trial before completion. No refunds will be made in such cases if necessary to cover incurred expenses.

ENTRY CONFIRMATION

Confirmation of entries will be made by the Field Trial Secretary by email as soon as practicable after receipt of the Entries and Payment. If you do not receive your confirmation by Tuesday, December 14, 2021 please notify the Carolinas EBGDC Field Trial Secretary at events@carolinasebgdc.com or call Cynthia Copeland (c) 803-507-3766.

To expedite organization, in the confirming email, the Field Trial Secretary will request the color of your dog(s) and the dog(s) call name.
